County of New Haven. }^{ss.} On this 3^d day of
November, A. D. 1866, personally appeared
before me, Judge of the Court of Probate for the
District of Guilford, in the County and State
aforesaid, Rev. George P. Wood, who being first
duly sworn according to law, deposes and says,
that he is Pastor of the Third Congregational Church
in Guilford, in said County, and State; that he is
well acquainted with Louisa D. Field of said
Guilford, who is a member of his Church; that on
the 7th day of April, 1862, he legally joined in
marriage Edmund P. Field and Louisa D. Dudley
both of said Guilford; that the marriage license which
authorized him to perform the marriage ceremony,
contained their names as above stated, and
that he made his certificate, and made his return
to the Registrar of said Town of Guilford, in accordance
with said license; He further says that the said
Louisa D. Dudley then married, is the identical
person who is now the widow of the said Edmund
P. Field, and who claims a pension as his widow.

He further says that he is informed, and after
careful inquiry, verily believes, that the said
Louisa D. Field was baptized by the name of
Deborah Louisa Dudley, and that in consequence
of her extreme aversion to the nickname of "Deb"
given by her schoolmates and others, she changed
