

was on the 30° day of December 1863, and now is a Justice of the Peace, Commissioner of said Superior Court within and for said County, duly appointed, commissioned and sworn, having full power and authority by the laws of this State, to take the acknowledgment of Deeds and other instruments, and to certify the same: also to administer Oaths, to take Affidavits and Depositions out of Court, and to give certificates thereof; that full faith and credit may, and ought to be given to his official acts and attestations; that the signature to the instrument hereto annexed, purporting to be his, I believe to be his genuine official signature; and that said instrument is executed, acknowledged and duly authenticated according to the laws of this State.
